THE MONTHLY MEETING OF THE COBB COUNTY RETIRED EMPLOYEES ASSOCIATION WAS HELD AT WEST COBB SENIOR CENTER WITH 29 IN ATTENDANCE. THERE WERE NO FIRST TIME ATTENDEES.

THE MEETING WAS CALLED TO ORDER BY **PRES. ROSWELL STORY**. THE INVOCATION WAS GIVEN BY **JOHN LASTER** FOLLOWED BY THE PLEDGE OF ALLEGIANCE TO THE FLAG. GET WELL CARDS WERE SENT TO **DOROTHY BARFIELD** AND **KITTY KILE**. WE WISH THEM BOTH A SPEEDY RECOVERY.

PRES. STORY INTRODUCED OUR SPEAKER, **THOMAS CAMPBELL**, U.S.ARMY. **MR. CAMPBELL** IS ACTIVE IN YOUTH MINISTRY IN HIS CHURCH. HIS SPEECH WAS "THE IMPORTANCE OF VALUES IN RELATIONSHIPS". HE EXPLAINED THAT PEOPLE HAVE DIFFERENT VALUES AND GAVE EXAMPLES. **MR. CAMPBELL** GAVE A VERY INFORMATIVE AND INTERESTING SPEECH.
