HE ALSO GAVE SOME EXAMPLES OF COURT CASES AND THE OUTCOME OF EACH. **JUDGE DODD** TOLD US ABOUT A SERIOUS ACCIDENT HE HAD FOUR AND A HALF YEARS AGO IN ORDER TO HELP US UNDERSTAND THE IMPORTANCE OF HAVING CERTAIN DOCUMENTS. IT WAS A VERY INFORMATIVE SPEECH. AFTERWARDS THERE WAS A QUESTION AND ANSWER SESSION.

RUBY LOWRY, TREASURER, REPORTED A BALANCE OF CASH ON HAND IN THE AMOUNT OF \$1,119.74. THE SECRETARY'S REPORT WAS REVIEWED AND A MOTION WAS MADE, ACCEPTED AND UNANIMOUSLY APPROVED TO ACCEPT BOTH.
