## **MINUTES**

## **February 18, 2008**

The monthly meeting of the Cobb County Retired Employees Association was held on Monday, February 18, 2008 at the West Cobb Senior Center with 64 members in attendance. Co-President Roswell Story called the meeting to order at 10:35 am.

The invocation was given by Harry Ingram followed by the Pledge of Allegiance to the Flag.

President Story welcomed new members and guests. He acknowledged our members who were absent due to illness: Mike Bolek, Ann Fitzgerald, Ralph Wheeler, Carolyn Landers, Kitty Kile and Nathan Wilson. Announcement was made of the death of long time member Harold Davis. It was also announced that Mary Gowder's son-in-law passed away.

Tom Scott, PhD from Kennesaw State University was introduced as guest speaker. Dr. Scott has written the *History of Cobb County* and *Cornerstones of Georgia History*. Highlights of his very interesting presentation were as follows: Before Cobb County was created the land was occupied by the Cherokee Nation and extended to the Chattahoochee River. The Cherokees had their own government, courts and economic structure, however, when gold was discovered in Dahlonega, Georgia the transition began. A railroad was constructed with Atlanta being developed at the southern extreme. Slavery made up 44% of the population in Georgia. The Civil War began and the Battle of Kennesaw was fought on June 27, 1864 and Atlanta fell on September 2, 1864. All except one building in Marietta was burned. All Cobb County public records were destroyed. Georgia went from being one of the richest to one of the poorest states since agriculture was the largest business. Segregation still existed with Lemon Street School in the City of Marietta being the only black high school.

Change began in Cobb County in 1941 with the outbreak of World War II. General Lucius Clay was placed in charge of building a commercial airport in Marietta. After Pearl Harbor the Air Force took over the airport and built the Bell Bomber Plant. Most of the employees were women. By 1945 there were 28,000 employees at the plant. Lockheed took over in 1951 and no women were allowed on the assembly line.

Population in Cobb County in 1900 was 25,000 and it jumped to 668,000 by 2005.

Lockheed was then run by Dan Houghton and the C-130 came into existence. With the growth of Lockheed many employees came to live in Cobb County. Along with the growth came parks and roads. By 1961 Lockheed had developed a desegregation plan which served it well when the political changes began to occur in 1964.

Ernest Barrett became the Chairman of the Board of Commissioners during this growth period. During his administration parks and libraries were built, roads were added and others improved and a sewer system was put into place.

The African American population in Cobb County in 1900 was 30%. By 1970 it was only 4%, however, in 2000 it was 19% and there is a large increase in minorities registered to vote today. Only 42% of Georgia's population are native Georgians.

David Hankerson became the first black county manager. Sam Olens the first Jewish Commissioner and Lee Rhyant the first black general manager of Lockheed.
