## COBB COUNTY RETIRED EMPLOYEES ASSOCIATION MINUTES February 18, 2013

The monthly meeting of the Cobb County Retired Employees Association was held on Monday, February 18, 2013 at the West Cobb Senior Center. There were 88 members and guests present. President David Stone called the meeting to order at 10:35 A.M.

Invocation was given by Gene Morris followed by the Pledge of Allegiance to the Flag. President Stone extended thanks to past president Roswell Story for his service to the organization.

President Stone extended our sympathy to the family of Harry Ingram who passed away recently.

**SPEAKER:** Cobb County Sheriff Neil Warren was guest speaker. Sheriff Warren spoke about our Second Amendment rights under the Constitution and also on Illegal Immigration. Sheriff Warren pledged to uphold the Constitution of the United States and the State of Georgia.

Sheriff Warren stated that the purpose of the Second Amendment is a reflection of our founding fathers giving individuals the right to protect themselves. In view of recent attempts to pass gun control legislation, Sheriff Warren stated that guns are not the problem but that the erosion of our families and moral decay are the problems. He pledged that he and his deputies will protect and defend the legal and constitutional rights of all the citizens of Cobb County. Sheriff Warren stated that the 1994 ban of assault weapons has done little to curb violence. He urged us to speak up and contact our Congressmen, the President or anyone else who will listen to urge them to not do anything to violate our Second Amendment rights.

On the subject of Illegal Immigration, Sheriff Warren stated that if an illegal immigrant is charged with a crime and brought to the Cobb County jail, it is his duty to notify any agency looking for the individual of the incarceration in Cobb County. At the beginning of the notification process there were 900 foreign individuals incarcerated and there are currently 300 open charges pending.

Sheriff Warren also stated that Representative Wendell Willard has proposed

legislation to take condemned cash and cars confiscated in drug cases away from the county and give to the state. This law, if passed, would take money that goes to drug units for use in fighting crime. He stated that the Sheriffs Association, District Attorneys Association and County Commissioners Association are against the legislation.

Sheriff Warren also urged the Cobb County Commissioners to enforce the federal program IMAGE to make sure any foreign person, employed by a company doing business with Cobb County, is a legal immigrant.
